Racial Roots of Firearms Registration

If you live in Michigan and own or want to own a handgun, you will be familiar with Public Act 381 that is the firearms law covering the purchase and ownership of a firearm in Michigan.

Perhaps the names *Clarence Darrow* and *Frank Murphy* sound familiar to you. How about Dr. Ossian Sweet?

It is because of a court case in 1925-26 involving Dr. Sweet and his lawyer Clarence Darrow that came before Judge Frank Murphy that Michigan adopted a "purchase permit" law for handguns.
